

COMPENSATION CIRCULAR CM-465

To: All Coal Mine Compensation Insurance Carriers

RE: **Proposal CM-3-2015**
Loss Cost Revisions
Approved Effective: April 1, 2016

The CMCRB submitted Proposal CM-3-2015 and the Pennsylvania Insurance Department approved this filing as submitted (including the revision for the provisions of House Bill 1846 submitted on December 16, 2015) to be effective April 1, 2016.

The approved Loss Costs reflect a 7.2% overall increase for Traumatic, a 0.0% overall change for State O.D. and a 10.5% overall decrease for Federal O.D. The approved Loss Costs reflect a 4.0% overall average increase across all classes and all coverages.

Attached is a two-page exhibit displaying the approved Loss Costs by class and by coverage, Employer Assessment Factor and USL&HW Rates. The Coal Employer Assessment Factor shall be 0.0170 effective April 1, 2016.

Each policy with an Anniversary Rating Date (ARD) on or after April 1, 2016, shall contain the newly approved Loss Costs and the revised Employer Assessment Factor. Such policies, if issued at the April 1, 2015 levels, shall be endorsed to include the newly approved values. No policy is permitted to be extended, or terminated and rewritten, to take advantage of, or avoid the application of, the newly approved Loss Costs and Employer Assessment Factor.

All experience mods/merit factors currently being issued for April policies and ARDs are being issued on a final basis. Also, USL&HW Rates are being issued on a final basis effective April 1, 2016.
