Proposed Loss Costs for Traumatic, State Occupational Disease and Federal

Occupational Disease Coverages To Be Effective: April 1, 2017

On November 23, 2016, the Coal Mine Compensation Rating Bureau of Pennsylvania ("Bureau") submitted the captioned filing for approval to the Pennsylvania Insurance Commissioner. The proposal requests the approval of an overall 3.7% decrease in manual loss costs. The attached exhibit displays the currently approved manual loss costs and the proposed manual loss costs by classification and coverage.

The Bureau's filing also includes a revision to the Employer Assessment Factor applicable to classifications under the Bureau's jurisdiction from 0.0170 to 0.0232.

Any policy with an Anniversary Rating Date on or after April 1, 2017, shall be issued on a tentative basis and should include the Pending Rate Change Endorsement (WC 00 04 04). The Bureau has received approval of a filing that eliminates Anniversary Rating Date provisions effective May 1, 2017 and published information on this filing under Compensation Circular CM-468 available on our website.
