

RE: **Proposal CM-5-2020**

Loss Cost Revisions

Approved Effective: April 1, 2021

The CMCRB submitted Proposal CM-5-2020 and the Pennsylvania Insurance Department approved this filing as submitted to be effective April 1, 2021.

The approved Loss Costs reflect a 1.8% overall decrease for Traumatic, a 0.0% overall change for State O.D. and a 1.5% overall increase for Federal O.D. The approved Loss Costs reflect a 1.3% overall average decrease across all classes and all coverages.

Attached is a two-page exhibit displaying the approved Loss Costs by class and by coverage and the approved Coal Employer Assessment Factor effective April 1, 2021. Please note that the USL&HW Rates displayed are tentatively effective April 1, 2021 ~~pending the final disposition of PCRB Filing No. C-379~~.

Each policy with an effective date on or after April 1, 2021, shall contain the newly approved Loss Costs and the revised Employer Assessment Factor. Such policies, if issued at the April 1, 2020 levels, shall be endorsed to include the newly approved values.

All experience mods/merit factors currently being issued for April policies and ARDs are being issued on a final basis.

Also, note that the CMCRB previously announced the approval of filings to eliminate ARD provisions effective May 1, 2017. These changes were announced in and provided with Compensation Circular CM-468.
